

# 2026 RESIDENTIAL EV CHARGER REBATE PROGRAM



## Rules & Requirements

---

- Only Anoka Municipal Utility (AMU) residential customers are eligible for rebates for purchasing Level 2 Residential EV Charger
- AMU residential customers must apply for rebates within twelve (12) months of the purchase date shown on the sales receipt.
- To qualify for this rebate, EV Charger must be Level 2. Level 1 and/or Level 3 Chargers do not qualify for rebate at this time.
- Limit of one rebate per customer account, per calendar year.
- Address with AMU service must be where the Electric Vehicle (EV) is stored.
- The EV Charger must be installed at the home residence of the customer applying with Anoka Municipal Utility (AMU) as the electric service provider.
- 200 amp bi-pass meter socket to feed EV charger must be installed. Proof of electrical permit may be requested.
- Customer must have completed inspections necessary and have proof if requested.
- Time-Of-Use (TOU) Program must be currently active before requesting for rebate.
- EV Time-Of-Use (TOU) meter must be currently installed and balance paid in full.
- Electric Grid Fee balance must be paid in full.
- AMU will issue rebate in the form of a check payable to the AMU customer on account.
- Receipt(s) submitted must be an original store-identified, dated sales receipt which includes the EV charger level description and price.
- AMU Customer signature/electronic signature is required. Customer must be listed on the AMU utility bill matching installation address for which rebate may apply.
- Failure to complete all rebate application information, or to provide information/documentation required will result in a rejection of the application.
- Applications will be accepted on a first-come, first-served basis.
- Rebate qualifications and amounts are subject to change at any time. AMU rebate programs may be cancelled or changed without notice. AMU customers should check with AMU to determine whether program changes have occurred and if rebate funds are still available.

## How to Apply

---



1. The customer understands the Rules & Requirements.
2. Applications **must** be post-marked or submitted to AMU **within 12 months of the receipt date**.
3. Select either the Online Application form, or the Printable Application to mail in for rebate submission.
4. Applications must be complete and include:
  - Dated sales receipt(s) uploaded in online rebate application form or copy of store-identified original mailed in with Printable Rebate Application.
  - AMU account holder signature.
5. Only complete applications will be processed. Submit signed application and receipt(s) online or by mail to AMU, Attn: Rebates, 2015 First Avenue, Anoka, MN 55303.
6. AMU will issue rebate in the form of a check payable to the AMU customer on account.

IMPORTANT: Please include a copy of a dated sales receipt/invoice including the charger description and cost. Limit one rebate per customer account for level 2 chargers purchased within the last 12 months, receipt must show purchase date. Charger must be installed where electric service is provided by AMU on a retail basis and where electric vehicle is housed. Rebate program is subject to change without notice. Rebate forms must be submitted within 12 months of purchase date. If you have any questions about completing this form, please call 763-576-2903. Please allow 6-8 weeks for rebate check.
